A CURRENT CUSTOMER WITH A SATISFACTORY ACCOUNT HISTORY MAY REQUEST NET 30 TERMS. THE ACCOUNT MUST HAVE ORDERED \$400 OR MORE PREVIOUSLY PER QUARTER AND BEEN IN BUSINESS FOR AT LEAST 5 YEARS. A REQUEST FOR NET 30 TERMS DOES NOT IMPLY APPROVAL. AN ACCOUNT GRANTED NET 30 TERMS MUST STILL PROVIDE CREDIT CARD BACKUP INFORMATION.
